RULES & REGULATIONS FOR EXHIBITOR

1. 3. Rights of an Exhibitor shall not be assignable to any other firm or person and Exhibitor may not assign his space or sublet the whole or any part of the space contracted for.

All lighting within the exhibit must be arranged and operated so as not to be distracting to adjacent exhibits. Phonograph radios or other sound devices operated in a manner objectionable to the Organizers shall be prohibited.

10. The execution of the Application and its receipt by AFMEC is deemed conclusive evidence of the Applicants agreement to pay the full fees due from the moment. The Application is non-cancelable by the Applicant further acknowledge that, having incurred expenses as a result of the contract/application is not required to refund any of the fees agreed to.

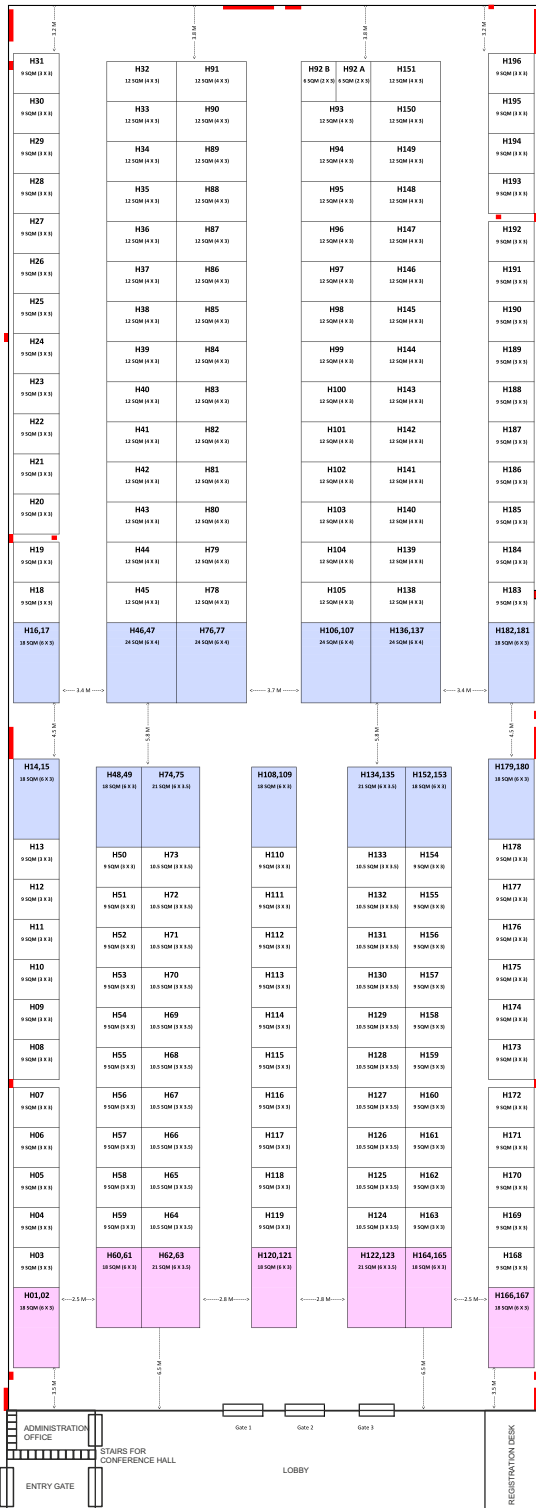

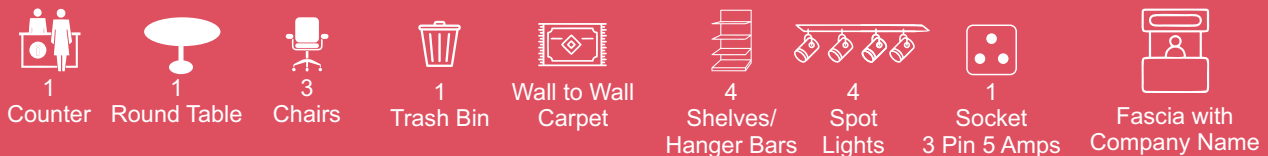

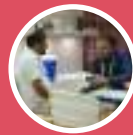
